

# Meds-to-Beds



This service allows patients to get medications delivered right to their bedside before being discharged from the hospital. Or, patients can come by the pharmacy before leaving the hospital. Meds-to-Beds is easy, convenient and can save a trip to an outside pharmacy, getting patients home faster.







#### WHAT IS MEDS-TO-BEDS?

Meds-to-Beds is a bedside service offered at Comanche County Memorial Hospital to enhance the patient's discharge process. Pharmacy staff will deliver discharge prescriptions directly to the patient prior to leaving the hospital room. Designed with our patients' health in mind, this program conveniently eliminates the need for a stop at the pharmacy on the way home. Upon request, the pharmacist will process your prescriptions and discuss your medication with you prior to your discharge.

#### Meds-to-Beds benefits:

- One less step for family members to worry about, letting them focus on patient care
- Allows the patient to concentrate on recovery
- The pharmacy can work with providers on medications not covered by your insurance
- Increased patient compliance and adherence to drug regimen
- Individualized medication counseling
- Family and caregivers can be involved in the counseling process in hospital room
- Eliminates the need for stopping at a pharmacy
- Reduces wait times
- Added privacy

## Frequently asked questions

# Can my prescription costs be added to my hospital bill?

No. Prescriptions filled by the Meds-to-Beds program are considered an outpatient pharmacy service and can not be added to your hospital inpatient bill. We are able to collect your copay when services are rendered.

#### Do you accept my prescription insurance plan?

We accept a majority of prescription insurance plans and directly bill your prescription to your insurance provider. You are responsible for any copay required by your insurance carrier when services are rendered.

## What types of payment do you accept for prescriptions?

The Meds-to-Beds program accepts personal checks, cash and credit cards.

## What if I forget to bring my prescription insurance card to the hospital?

The CCMH Pharmacy will gladly call your current pharmacy and retrieve your insurance information.

#### How do I request to participate in the Meds-to-Beds program?

Let your nurse or doctor know you would like the CCMH Pharmacy to fill your prescriptions at discharge. We will take care of the rest.

Patients have the right to choose any pharmacy for their prescription services. Meds-to-Beds provides a convenient service to both the patient and family. The patient is able to travel uninterrupted to their home to continue the healing process. Any hometown pharmacy can the call CCMH Pharmacy at 580.250.5850 and request a transfer for further refills.
